**Fresh Cases**


**Case No. 01**

**(Shri Vaibhab Verma and Smt. Sapna Verma, D-123,3<sup>rd</sup> floor, Saket, New Delhi)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of residential building with Basement + Stilt + GF+ 3 floors with the total height of 18.00 mtrs (including mumty, parapet, water storage, tank etc.) at D-141, Saket, New Delhi with floor area of Stilt=GF= FF = SF= TF = 156.75 Sqmt and Basement = 156.74 Sqmt and Depth = 3.45 mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Delhi. The applicant should follow the local building bye-laws while constructing the building.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction and reconstruction of commercial building with GF + 4 floors with the total height of 17.88 mtrs. (Including mumty, parapet, water storage, tank etc.) at C.S.No. 5 A/1 South Kasba Near Damani Complex Laxmi Market Road Datta Chowk, Dist. – Solapur – 413007 with GF=52.64 Sqmt, FF = SF = TF =FF=61.48 Sqmt, Basement=32 Sqmt, 2.40 mtrs below G.L, lift pit= 1.50 mtrs, below basement for total depth of below G.L= 3.90 mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Maharashtra.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of residential and commercial building with GF + 2 floors with the total height of 14.35 mtrs. (Including mumty, parapet, water storage, tank etc.) at C.T.S.No.-4650/A/1, Near Vishal Ganpati Mandir, Maliwada with GF=40.15 Sqmt, FF=SF=87.05 Sqmt, lift well depth= 1.025 mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Maharashtra.

### **Case No. 12**


**(Shri Vilas Dagdu Korke, 4678, Bhopale, Lane, Maliwada, Dist. – Ahmednagar – 414001.)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for re-construction of residential building with Parking+ Stilt + 3 floors with the total height of 15.35 mtrs. (Including mumty, parapet, water storage, tank etc.) at CTS No. 4616, Bhopale Lane, Maliwada, Ahmednagar – 414001. With Parking = 8.16 mtrs, Stilt= FF=SF=45.78 and TF=03.46 Sqmt.The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Maharashtra.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of residential building with GF + 1 floor with the total height of 09.05 mtrs. #### **Case No. 17**

After perusal of the application, it was decided to **send back** the case asking the applicant to restrict the maximum height of new construction in the regulated area of the CPM "Shaniwarwada" at 24. 00 meters between 200-300 meters from the CPM (inclusive all) in view of the existing dense constructions around the CPMs which posed threat to its safety and preservation.

The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Maharashtra.
