ITEM No.1: Preparation of Impact Assessment Report for Jogeshwari Caves, Mumbai

The Regional Director and Competent Authority, Mumbai informed that he approached J.J. School of Architecture, Mumbai, INTACH Mumbai, and Smt. Radhika Dhumai, Conservation Architect to prepare Heritage Impact Assessment Report for Jogeshwari Caves, Mumbai. The J.J. School of Architecture informed their willingness to prepare the Report only with the help of NEERI, Nagpur. INTACH informed that they are ready to prepare the report but they would not submit any bid for the project. After discussion, it was decided to direct the Competent Authority to obtain the estimated expenditure for preparation of the Report from INTACH along with a tentative time schedule. The Additional Expenditure for adding large scale maps in the report should also be indicated.

ITEM No. 2: Online Application for Construction of building by M/s Sai Universal Realtors and Developers, Mumbai

The online application forwarded by Competent Authority, Mumbai was considered. It was observed that the proposed 7 Storey Building will be constructed after demolition of existing structure and therefore, it should be considered as a new construction. The Authority decided that the application should be routed through the Single Window Portal of Municipal Corporation of Greater Mumbai.

ITEM No. 3: The reference made by Regional Director and Competent Authority, Bhopal regarding 8 NOC cases of public project

The 8 cases referred by Competent Authority, Bhopal had been considered by NMA in its 152nd meeting and approved subject to certain conditions. Competent Authority, Bhopal requested to reconsider these cases as the Sites of Construction are within the prohibited area of Centrally Protected Monuments.

The Authority looked into the application once again and observed that the definition of Construction has been defined in Section 2(dc) of the AMASR Acct, 1958 in which construction of drains, drainage works, Public latrines, Urinals and similar conveniences are not included within the term "Construction". Therefore, the Authority recommended grant of NOC in these cases for construction of toilet, Pavement etc. under Rule 6(iii)& (iv) and Rule 7 of the AMASR (Framing of Heritage Bye laws and other functions of Competent Authorities) 2011. As regards construction of Interpretation and Mediation Centre at Bharhut, District Satnam, Madhya Pradesh, the Authority decided that the NOC is granted subject to the condition that construction of the Interpretation and Mediation Centre should be constructed by either ASI themselves or under their supervision.
