Case no. 1

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Ground floor with the total height of the building 4.50 mtrs (including mummy parapet, water-storage, lift machine room etc.) at Survey No-136, Andhra Pradesh, YSR District, Rajampetha, Nandalur; with floor area of GF=79.38 sqm.
