**Consideration of Online Cases, Non Single window and public projects**

**Case no. 250**

**(Smt Ruma Choudhury, B-71, Inderpuri, New Delhi)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of 17.98mtrs (including mumty, parapet, water-storage tank, lift room etc.) at C-17, Hauz Khas Enclave, New Delhi; with floor area of Stilt=GF=FF=SF=TF=187.48 sqm and basement = 187.48 sqm with depth = 3.20 mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi.

## **Consideration of Non-single window case**

### **Case no. 01**

**(Md. Wasif, Street No 6, Plot No 293, Lalita Park, Laxmi Nagar, Delhi - 110092)**

After perusal of the application, it was decided to **reject** the case as the applicant has violated the Act and carry out the unauthorized construction on the proposed site.

## **Public Projects**

### **Case no. 01**

**(Shri Suresh Pal, Executive Engineer (SRD-I), Executive Engineer, SRDP-I, Western Yamuna Bank, IP Estate, New Delhi)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for redevelopment/renovation of existing road, footpath, water lines & sewer lines of Chandni Chowk Road from Lal Jain Mandir to Fatehpuri Mosque, New Delhi.

### **Case no. 02**

**(The Chief Officer, Phaltan Municipal Council, Ravivar Peth, Phaltan, Tal-Phaltan, Dist- Satara-415523)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of shopping centre and parking of GF+terrace parking with the total height of 6.80mtrs (including mumty, parapet, water-storage tank, etc.) at C.T.S. No. 3431/D1 Reserve No. 54, Ravivar Peth, Phaltan, Dist- Satara, Maharashtra; with floor area of GF (shop) = 192.27 sqm, GF (parking) = 582.30 sqm, covered area terrace = 586.19 sqm.

After perusal of the above mentioned applications and Powerpoint Presentation made by the applicant, it was decided that the NMA will visit the site, once the applicant submit the leftover proposals to Authority for consideration. During the visit of NMA to Agra, discussions will be held with the SA, Agra Circle and his team to ascertain their views.

**Case no. 09**

**(Chief Officer, Town Municipal Council, Badami, near PCARD Bank, Badami, Bagalkot-587201)**

After perusal of the application, it was decided to **recommend** grant of NOC for the following proposals:

1. Construction of Entrance Arch at Ambedkar Circle from Physical Remains
  - a) Excavation depth from Natural Ground level- 3.0m
  - b) Height of proposed construction from road level- 9.75m
  - c) Span of Arch- 8.0m (out to out)
  - d) Pillar size- 1.0m x 1.0m
  - e) Description of pillars & beam- RCC frames arch with Sand Stone (with carved sculptures) cladding
  
2. Construction of Pedestal & Installation of Statue of Pulikeshi at Ramadurga Cross from Physical Remains
  - a) Excavation depth from Natural Ground level- 2.0m
  - b) Height of proposed statue from road level- 5.25m
  - c) Diameter of Pedestal- 3.0m

at Museum Road, Caves Road & Ramadurga Cross, Badami Taluk, Bagalkot District.

For Construction of Entrance Arch at Tangakoot from Physical remains- it was decided that the project to be shifted beyond 100mtrs limit of the Centrally Protected Monument and revised layout should be submitted accordingly.
