**Case no. 408/1**

**(Mr. Sandeep Mani, B.P. no. 17, Nizamuddin East, New Delhi)**

After perusal of the application and site visited by Members of NMA, it was decided to **recommend** grant of NOC in this case for addition/alteration on existing GF+1 floor with the total height of the building restricted to 10.8 mtrs (including mummy parapet, water-storage, etc.) at B.P. no. 17, Nizamuddin East, New Delhi; with proposed floor area of GF = 320.085 sqm and FF= 112.848 sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Delhi. The applicant should follow the local building bye-laws while constructing the building. The earlier NOC stands cancelled.



**Case no. 417**

**(M/s Christian Inst for the study of religion and society through its Dir Mr. Rev Vincent Rajkumar, Plot no. 14, Jungpura –B, Mathura Road, New Delhi)**

After perusal of the application, it was decided to **reject** the case as there is height mismatch as per Form-I and Architectural designs.

**Case no. 418**

**(Mrs. Ratna Rao, S-91, Panchsheel Park, New Delhi)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for addition/alteration of existing Basement+GF+2 floors with the total height of the building restricted to 13.53 mtrs (including mummy parapet, water-storage, lift machine room etc.) as per architectural drawings at S-91, Panchsheel Park, New Delhi with proposed additional floor area of GF=FF=SF= 5.08 sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Delhi. The applicant should follow the local building bye-laws while constructing the building.
