Consideration of Online Cases

Case no. 235

(Smt Soradini Kongkal Sangma Thor Its Gpa Mr Sumder Lal Yadav, D-289, Sarvodaya Enclave, New Delhi-110017)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of 18mtrs (including mumty, parapet, water-storage tank, lift room etc.) at D-289, Sarvodaya Enclave, New Delhi-110017; with floor area of Stilt = GF = FF= SF=TF = 125.25 sqm. and Basement = 125.25 sqm with depth = 3.20 mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi.
