VACANCY CIRCULAR

Subject: Engagement of One (01) Consultant for Hindi related work in National Monuments Authority under Ministry of Culture amongst retired officers from Pay Level- 8 to Level- 11 of the cadre of Rajbhasha, Department of Official Language - reg.

The National Monuments Authority (NMA), a statutory body under Ministry of Culture, New Delhi intends to engage one (01) retired Central Government employee who retired from the Pay Level -8 to Level -11 of the cadre of Rajbhasha, Department of Official Language to work as **Consultant (Hindi)** to assist the Authority in undertaking comprehensive activities to promote use of Official Language in official work in the Authority and also to provide assistance in translation of documents, implementation of OL policy and relevant assignments.

2. Accordingly, the willing and eligible candidates may send their bio-data as per Annexure-I attached, through email at director@nma.gov.in addressed to Director, NMA, 24 Tilak Marg, New Delhi latest by 13.01.2025 . The eligibility, terms & conditions and remuneration are as under: -

Eligibility:

- (i) Must have retired from the Pay Level-8 to Level -11 of the cadre of Rajbhasha, Department of Official Language.
- (ii) Must be well acquainted with the functioning of Government/Ministries and having experience of translation from Hindi to English and vice-versa.
- (iii) Must have proven experience & expertise in translating the Government Reports/ laws.
- (iv) The maximum age of Consultant shall be 63 years on the closing date of receipt of applications i.e. 13.01.2025.

Remuneration:

- (i) The remuneration shall be an amount equal to the last pay drawn minus pension plus Transport Allowance drawn at the time of retirement, in terms of Department of Expenditure's OM No. 3-25/2020-E.IIIA dated 09.12.2020.

Terms & Conditions:

- (i) The initial engagement of a person as Consultant shall be for a period of one (01) year, which can be extended on yearly basis, based on requirement of NMA and performance of the Consultant concerned.
- (ii) The Consultant should maintain absolute confidentiality and secrecy of the information handled by him/her during the contract and even after termination of contract, failing which the consultant will be liable for suitable action, as deemed fit.
- (iii) The Consultant shall have to perform duties/ services as assigned to him/her by his/her controlling officer with all the necessary skills, diligence, efficiency and economy.
