**Delhi Case no. 602**

**(Mr. Vipin Goel, B-7/97 Safdarjung Enclave, New Delhi)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Stilt+GF+3 floors with the total height of 18.00 mtrs (including mumty, parapet, water storage tank etc.) at B-7/97 Safdarjung Enclave, New Delhi; with floor area of Stilt = Ground Floor = First Floor = Second Floor = Third Floor = 111.05 Sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Delhi. The applicant should follow the local building bye-laws while constructing the building.

Part-1 New Delhi-110049; with floor area of Basement = 125.38 Sqmt with Depth = 3.20 Meters and Stilt = Ground Floor = First Floor = Second Floor = Third Floor = 125.38 Sqm. After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Stilt=GF+3 floors with the total height of 13.4112 mtrs (including mumty, parapet, water storage tank etc.) at Survey No. 466/1, Ward No. 20: Door, Car Street Agriculture College Road, Bapatla, Guntur; with floor area of Stilt=GF= FF=SF=TF=221.10 sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Andhra Pradesh.
