Consideration of Online Cases

Case no. 251

(Shri Rajendra Ahuja, 14-15, Swastik Enclave, Pocket-8-A, Sector-15, Rohini, Delhi)

Member Secretary informed that the case has been rejected as the applicant has submitted the proposal for construction of building with a total height of 19.63 mtrs (inclusive all) which is not as per the guidelines of building Byelaws, MPD 2021.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Stilt+GF+3 floors with the total height of 18mtrs (including mumty, parapet, water-storage tank, lift room etc.) at P.N.-57, Block-C at Veer Nagar, Jain Colony, Delhi-07; with floor area of Stilt=GF=FF=SF=TF=145.38 sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi.

Case no. 253

(Smt. Manisha Israni, Ms. Pinky Narang, Smt. Samta Kumari, Shri Upkar Mani, Plot no.G-48, Situated at Green Park Main, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for addition/alteration of GF+3 floors with the total height of 15.05mtrs (including mumty, parapet, water-storage tank, lift room etc.) at Plot no.G-48, Situated at Green Park Main, New Delhi; with floor area of Existing covered area on GF =139.34 sqm, Existing covered area on FF= 109.15 sqm, Proposed covered area on SF= 109.15 sqm, Proposed covered area on TF= 109.15 sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi.
