

Consideration of Online Cases

Case no. 218/1

(M/s Pal & Paul builders Ltd through its Director Sh Amit Pal Singh Goller, F-6, Geetanjali Enclave, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of 18mtrs (including mumty, parapet, water-storage tank, lift room etc.) at F-6, Geetanjali Enclave, New Delhi; with floor area of Stilt=GF=FF=SF=TF=187.44 sqm. and basement = 187.44 sqm with depth= 3.00 mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi.



Case no. 251/1

(Shri Rajendra Ahuja, 14-15, Swastik Enclave, Pocket-8-A, Sector-15, Rohini, Delhi New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Stilt+GF+3 floors with the total height of 17.97mtrs (including mumty, parapet, water-storage tank, lift room etc.) at plot no. A-39 & A-40, Gur ki Mandi, Delhi; with floor area of Stilt=GF=FF=SF=TF=87.50sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi.

1) (Case of Prena Infrabuild Ltd. Ahmedabad, Gujarat)

After perusal of the application on the re-development of existing Flats on plot no. 280, located in Town Planning Scheme 26 of Vasna Ext., Vasna, Sabarmati, Ahmedabad, it was decided to inform the applicant that any construction work including the construction of boundary wall, should take place beyond 300 mtrs limit from the nearby CPM, Competent Authority, Gujarat and SA, Vadodara circle may also be informed about the representation.
