Consideration of Online Cases

Case no. 191

(Smt. Sheela Gehlot, A4-5, Mayfair Garden, Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 Floors with the total height of 18mtrs (including mumty, parapet, water-storage tank, lift room etc.) at 1/8, Sarvapriya Vihar; with floor area of Stilt=GF=FF=SF=TF=143.46 sqm and basement area = 88.29 sqm with depth -3.20 mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi.

Case no. 192

(Shri Avinash Chand Jain, Veer Nagar Jain Colony, Delhi)

After perusal of the application, it was decided to **reject** the NOC as the proposed site falls in the prohibited area of "Tripolia Gateway" which is at a distance of 97mtrs according to the site inspection report submitted by CA, Delhi.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Stilt+GF+3 floors with the total height of 18 mtrs. (including mumty, parapet, water-storage tank, lift room etc.) at Plot No. 123, Block-G, Veer Nagar, Jain Colony, Delhi; with floor area of Stilt=GF=FF=SF=TF=78.127 sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Stilt+GF+3 floors with the total height of 18 mtrs. (including mumty, parapet, water-storage tank, lift room etc.) at Plot No. 138, Block-H in the layout plan of the displaced Jain CHBS Ltd., Veer Nagar, Jain Colony, Delhi; with floor area of Stilt=GF=FF=SF=TF=122.733 sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 Floor with the total height of 7.7 mtrs. (including mumty, parapet, water-storage tank, lift room etc.) at C.T.S. No. 46 & 47 Survey No. 241/1 At Pathardi Shiwar, Nashik; with floor area of GF=308.56 sqmt. FF=121.07 sqmt.

(Shri Randhir Dwarkadas Gujrathi & Other, 112, Sarda Sankul, M.G. Road, Nashik-422001, Maharashtra)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF/Parking+4 floors with the total height of 18.15 mtrs. (including mumty, parapet, water-storage, tank, lift room etc.) at Plot No. 18A, S. No. 288/2+3/4A+288/3B/16 of Pathardi Shiwar in Nashik; with floor area of GF/Parking=FF=SF=TF=FF= 76.80 sqm.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF/Parking+4 Floors with the total height of 18.15 mtrs. (including mumty, parapet, water-storage tank etc.) at Plot No. 25 B, S. No. 288/2+3/4A + 288/3B/24 of Pathardi Shiwas in Nashik; with floor area of GF/Parking=FF=SF=TF=FF= 73.20 sqm.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF/Parking+4 floors with the total height of 18.15 mtrs. (including mumty, parapet, water-storage tank etc.) at Plot No. 18 B, S. No. 288/2/3/4A/288/3B/17, Pathardi, Nashik; with floor area of GF/Parking=FF=SF=TF=FF= 76.80 sqm.
